DIAMOND 7 Arena, Dillsburg, PA

General Futurity Rules

1. Any APHA-eligible weanling or APHA-registered horse may be nominated for each eligible class by a nominating payment of \$30.00, by May 1st, plus a sustaining payment of \$30.00, by July 1st, or one payment of \$120.00 from July 1st to September 1st, or one payment of \$180.00, from September 2nd to September 14th. Nomination dates are determined by postmark, nor notated receipt by PPHC official. **NO ENTRIES WILL BE ACCEPTED ON SHOW DAYS.**
2. Owner and exhibitor must be PPHC members by first show day. Non-pro exhibitors must show a current APHA Amateur, Novice, or Youth card by first show day. PA-BRED entries must be foaled in PA, owned and shown by PA resident, with current PPHC membership.
3. Copies of APHA registrations must accompany each entry; weanlings may show with APHA registration application with Breeder's Certificate. Transfer of ownership does not affect eligibility, but NEW owner must show copy of completed transfer, or new registration certificate, and current PPHC membership.
4. Solid Paint-Bred/Breeding Stock are eligible for all Futurity classes.
5. Substitutions may be made only within the same class or division. **NO SUBSTITUTIONS ON FUTURITY DAYS.**
6. All Futurity entries must complete a regular show entry form with the show secretary to receive an exhibitor number, and then check in with the Futurity Chairman.
7. Classes will be placed by each judge through all horses showing, then overall placings will be announced. A Tie-Breaker Judge will be chosen for each class, prior to the start of the show.
8. No refunds without a vet certificate of injury, illness, or death.
9. Entries are subject to drug testing with automatic disqualification for testing refusal, or positive test results.
10. APHA rules apply in all Futurity classes.
11. All Futurity Classes are eligible for APHA PAC Points.
12. 10% of all nomination fees will be held back for expenses. Any added monies will be divided equally among all classes by number of entries actually showing. All nomination fees, and fees from entries eventually scratching from competition will accrue to classes originally entered. Payback is based on number of horses actually showing in each class, and will be mailed to owner, or designated recipient, by September 30th.
