

# Pennsylvania Paint Horse Club 2008 General Futurity Rules

To promote, encourage and reward all Paint Horse Breeders and Exhibitors

1. Any APHA eligible weanling or APHA registered horse may be nominated for each eligible class by one payment of \$50 by July 1<sup>st</sup>, or \$100 from July 2<sup>nd</sup> thru September 12<sup>th</sup>. Date of nomination will be determined by postmark, or notated receipt by PPHC official.

## Eligible Classes:

F1.	Weanling Colts & Geldings	F9.	Yearling Longe Line
F2.	Yearling Colts	F10.	2 & 3 Yr. Old Hunter Under Saddle
F3.	Yearling Geldings	F11.	Non-Pro Jr. Hunter Under Saddle 2-5 Yr. Olds
F4.	Non-Pro Weanlings (All Sexes)	F12.	4 & 5 Yr. Old Hunter Under Saddle
F5.	Weanling Fillies	F13.	2 & 3 Yr. Old Western Pleasure
F6.	Yearling Fillies	F14.	Non-Pro Jr. Western Pleasure 2-5 Yr. Olds
F7.	Non-Pro Yearlings (All Sexes)	F15.	4 & 5 Yr. Old Western Pleasure

2. Owner and exhibitor must be PPHC members by September 13<sup>th</sup>, 2008.
3. Copies of APHA registrations must accompany each entry; weanlings may show on registration application/breeder's certificate. Transfer of ownership does not affect eligibility, but new owner must show completed transfer or new registration and PPHC membership.
4. Solid Paint-Bred/Breeding Stocks are eligible for all futurity classes.
5. Substitutions may be made only within the same class or division.
6. All futurity entries must complete a regular show entry form with the show secretary to receive an exhibitor number, and then check in with the futurity chairman.
7. Classes will be placed by each judge thru all entries showing, and then overall placings will be announced. A tie-breaker judge will be chosen prior to each class.
8. No refunds will be given without a veterinarian certificate of injury, illness or death.
9. Entries are subject to drug testing, with an automatic disqualification for testing refusal, or positive test results.
10. APHA show rules apply in all futurity classes.
11. All futurity classes are eligible for APHA PAC points.
12. 10% of all nomination fees will be held for expenses. All nomination fees accrue to classes originally entered. Any added monies and fees collected from entries that scratch will be divided equally among all entries that show.
13. Payback is based on number of entries that actually show and will be mailed to owner or designated recipient by October 1<sup>st</sup>.
14. There will be a \$35 charge for any returned checks.
